

**North Dakota State College of Science and North Dakota State University
Articulation Agreement**

The purpose of this memorandum is to clarify and set forth the essential terms of agreement between the two institutions relating to curriculum requirements to be satisfied for any student attending the North Dakota State College of Science's Associate of Arts in Liberal Arts – Business Transfer program and Associate of Arts in Liberal Arts – General Transfer program who desires admission into North Dakota State University, College of Business – Business Administration program.

North Dakota State College of Science (hereafter NDSCS) has established an Associate of Arts Degree, Liberal Arts – Business and an Associate of Arts Degree, Liberal Arts – General, and the North Dakota State University (hereafter NDSU) has established a Bachelor of Science in Business Administration and will facilitate credit transfer and provide a smooth transition from one related program to another. It is mutually agreed:

Admission and Graduation Requirements

- A. NDSU's admission and program admission requirements apply to both direct entry students and to students who transfer under this agreement.
- B. Students must fulfill the graduation requirements at both institutions. NDSU requires that students complete 60 credits from a four-year institution.
- C. NDSCS students must complete the entire associate liberal arts – business transfer program or the associate liberal arts – general transfer program. The grades of the transfer courses applicable to the professional program requirements of NDSU College of Business must be 'C' or higher. Otherwise, the students will need to retake those courses after admitted.
- D. Students who have completed an associate of arts or an associate of science degree are considered to have completed NDSU's lower-division general education requirements.

Transfer of Credits

- A. In order to complete NDSU's Bachelor of Science in Business Administration program, a total of 120 credits are required.
 - a. For NDSCS students graduating with the associates of arts degree, liberal arts – business (AA-B), approximately 66 NDSCS credits will be transferred into NDSU's Business Administration program. If not already completed as electives through the NDSCS program, the student will complete 6 credits of lower-division College of Business (CoB) requirements and 3 upper level English credits. Forty-five (45) additional upper-division, major credits are also required.
 - b. For NDSCS students graduating with the associates of arts degree, liberal arts – general (AA-G), approximately 65 credits will be transferred to NDSU's

Business Administration program. If not already completed as electives through the NDSCS program, the student will complete 2 credits of lower-division CoB requirements and 5 free elective credits. Forty-eight (48) additional upper-division, major credits are also required.

- B. NDSCS students are encouraged to take some courses at NDSU through the use of the already established Tri-College University System to ensure ease of transfer:
 - a. It is recommended that students take MGMT 320: Foundations of Management and/or MRKT 320: Foundations of Marketing at NDSU.
 - b. Interested NDSCS students should visit with their NDSCS advisor to complete the Tri-College form.
 - c. NDSU College of Business agrees to provide AA-B and AA-G students an exemption of the college prerequisites for MRKT 320 or MGMT 320 through Tri-College.
 - d. Should the MRKT 320 or MGMT 320 classes be closed, contact the CoB Department of Management and Marketing staff for possible permissions.
- C. College of Business courses completed in previous semesters are considered valid for NDSU degree requirements if taken within the previous five years. College of Business coursework taken before the five-year limit may be reviewed by the NDSU College of Business Student Progress Committee to determine its appropriateness to the current major requirements.
- D. See attached Program Articulation Tables for full details.

Implementation and Review

- A. The College and University Administrators or designees of the parties to this agreement will implement the terms of this agreement, including identifying and incorporating any changes into subsequent agreements, assuring compliance with system policy, procedure and guidelines, and conducting a periodic review of this agreement.
- B. This Articulation Agreement is effective on 01/1/2021 and shall remain in effect until the end date of 12/31/2025 or for five years, whichever occurs first, unless terminated or amended by either party with 90 days prior written notice.
- C. The college and university shall work with students to resolve the transfer of courses should changes to either program occur while the agreement is in effect.
- D. This Articulation Agreement will be reviewed by both parties beginning 6/30/2025 (within six months of the end date).
- E. When a student notifies NDSU College of Business program of their intent to follow this agreement, the NDSU will encode waivers, substitutions, and permissions necessary.

- 6 credits of NDSU CoB requirements are not met via NDSCS requirements, i.e., STAT 331 (2 credits) and MATH 144 (4 credits). Math 146 @ NDSCS is an automatic substitution for MATH 144 @ NDSU.
- 3 credits of Upper Division General Education are not satisfied via AA, i.e., ENGL 320 (3 credits). ENGL 125 @ NDSCS is equivalent to ENGL 320 @ NDSU.
- 45 credits remaining to fulfill the Business Administration major requirements, assuming that MGMT 320 or MRKT 320 is taken at NDSU through Tri-College.


- 48 credits remaining to fulfill upper division major requirements, assuming that MGMT 320 or MRKT 320 has not been taken at NDSU through Tri-College.
