What is a Strategic Plan?

A strategic plan communicates institutional priorities, goals, and a plan to achieve those goals. Strategic planning involves stepping back from day-to-day operations and asking where the institution will be focused, what actions will be taken to achieve the goals, and how the institution will know if the goals have been achieved.

It helps the institution carry out its mission, comply with regulations, stay fiscally and operationally healthy and focus on the future.

A strategic plan typically includes:

- · An explanation of the planning process
- The institution's mission, vision and values
- Goals, objectives, and strategic issues
- Strategies, tactics and actions to achieve goals
- Metrics and key performance indicators (KPIs) to measure success

The 2025-2035 NDSCS Strategic Plan was developed over the past several months as a collaborative process involving both campus and community stakeholders.

The approved strategic plan will be available on the NDSCS website and on the Intranet soon.


